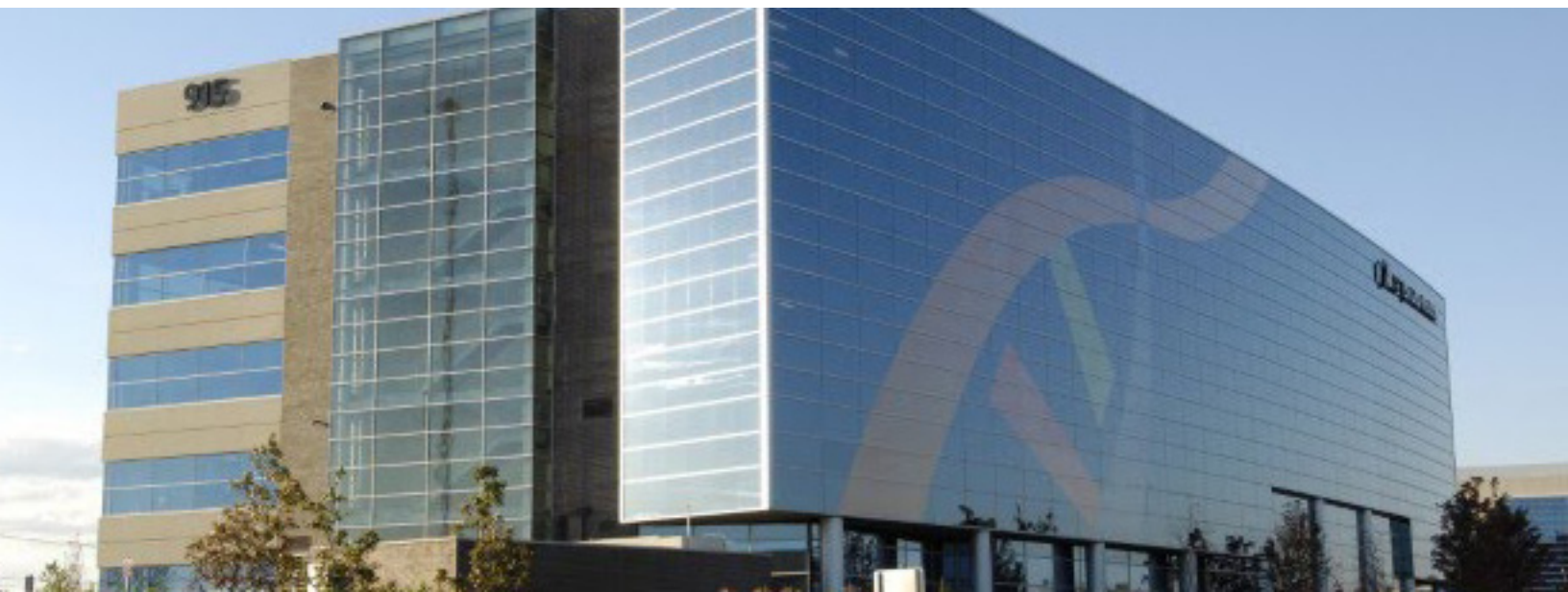
# Welcome to The Fourth Annual Ruberg SYMPOSIUM
